

**KENT COUNTY GOLF UNION**  
**THE JUNIOR (CLUB) CHAMPIONSHIP**

**Championship Rules**

1. **Eligibility:** The Junior Club Championship is open to teams of 3 members from the same Club who have properly been accepted as individual entrants for the Kent Junior Championship.  
  
A Club may enter more than one Team to represent them.
2. **Teams must be nominated by their Club before any player in the Team strikes his first shot.**
3. A player may only represent one Club in the Championship.
4. **The Junior Club Champions:** will be the Team who return the lowest aggregate nett score from the best two scores in the am and pm rounds of the Junior Championship.  
In the event of a Tie the decision will be by aggregate "count-back".
5. All other pertinent Rules will be as for the Junior Championship.
6. The Club Champions will qualify to represent the County in the Junior Club Champions Competition.
7. **Ride on Buggies.** Except in cases when Competitors claim exemption under the provisions of the Disability Discrimination Acts 1995 and 2005 upon the production of a Medical Certificate signed by a Registered Medical Practitioner, all other Competitors shall be prohibited from riding on motorised buggy carts, except with the explicit permission of the Championship Committee. Penalty for Breach of Condition is Disqualification. Medical Certificates must be provided to the Secretary no less than 5 clear days prior to the start of any competition administered by the Union. Competitors shall always be responsible for providing their buggy.
8. **Distance Measuring Devices (DMD's)** are permitted but only those that calculate distance. Those providing other information such as wind speed, temperature and elevation, will not be allowed. Any player found using such a DMD will be in breach of Rule 14-3 for which the penalty is disqualification, regardless of whether any such additional function is actually used.
