Notes for Competitors

- 1) Entrance fee is £30.00 - under 18 years £23.00. Please register with the County Secretary in the clubhouse on arrival.
Handicap certificates must be shown.
- 2) PLAYERS ARE NOT ALLOWED CADDIES OR TROLLEY PULLERS.
- 3) **If for any reason you cannot play please advise the County Secretary immediately.**
- 4) If you are in doubt about play being possible because of bad weather, please ring the County Secretary or the Club.
DON'T JUST NOT TURN UP.
- 5) **Collect your card from the starter.**
- 6) Slow play may be penalised. If you lose a ball, call the next players through whilst you look for the ball.
- 7) LUNCHES have been booked for all competitors. **NO REFUNDS WILL BE GIVEN. ANY EXTRA LUNCHES MUST BE ORDERED FROM THE STEWARD 72 HOURS IN ADVANCE OR THERE WILL BE NO GUARANTEE THAT FOOD WILL BE AVAILABLE.**
- 8) JACKETS AND TIES MUST BE WORN IN THE DINING ROOM AND FOR THE PRESENTATION.
- 9) **PLEASE HAND YOUR COMPLETED CARD TO THE RECORDERS IN THE CLUBHOUSE IMMEDIATELY UPON LEAVING THE COURSE. DELAY IN SO DOING WILL DELAY FINALISING OF THE RESULTS, AND EVERYONE WHO WOULD LIKE TO GO HOME.**
- 10) DISTANCE MEASURING DEVICES (DMD'S) ARE PERMITTED BUT ONLY THOSE THAT CALCULATE DISTANCE THOSE PROVIDING OTHER INFORMATION SUCH AS WIND SPEED, TEMPERATURE AND ELEVATION, WILL NOT BE ALLOWED. ANY PLAYER FOUND USING SUCH A DMD WILL BE IN BREACH OF RULE 14-3 FOR WHICH THE PENALTY IS DISQUALIFICATION, REGARDLESS OF WHETHER ANY SUCH ADDITIONAL FUNCTION IS ACTUALLY USED.
- 11) PLEASE NOTE THAT THE PRIZES FOR ROYAL CINQUE PORTS, PRINCE'S AND LITTLESTONE WILL BE PRESENTED AFTER PLAY AT LITTLESTONE.
- 12) Except in cases when Competitors claim exemption under the provisions of the Disability Discrimination Acts 1995 & 2005 upon the production of a Medical Certificate signed by a Registered Medical Practitioner, all other Competitors shall be prohibited from riding on motorised buggy carts, except with the explicit permission of the Championship Committee. Penalty for Breach of Condition is Disqualification. Medical Certificates must be provided to the Secretary not less than 5 clear days prior to the start of any competition administered by the Union. Competitors shall always be responsible for providing their buggy.
- 13) Competitors must conform in all respects with the dress rules of the host club both on and off the course.
